PART E – SPECIFICATIONS

- Revise: E4.3.2 to read: The Contractor shall perform the Work, including all Collection, in accordance with the Contract and the **reviewed** Implementation Plan.
- Add: E7.7 (e) Provide Collection Vehicle location by GPS coordinates.
- Delete: E7.8 Provide Collection Vehicle location by GPS coordinates.
- Add: E10.1 (a) (i) Sweep Collection is estimated to be approximately 70 to 150 hours per month, from the beginning of May until the end of September for each year. Sweep Collection is generally performed from Monday through Friday on the first week and the last week of the month or at any time as required by the Contract Administrator.
- Add: E10.1 (b) (i) Area Cleanup is estimated to be approximately 25 to 100 hours per month. Area Cleanup shall be performed on an as required basis from Monday to Friday.
- Add: E10.3 The Contractor shall perform the Extra Work without interrupting or halting the Work of the Contract.

QUESTIONS AND ANSWERS

- Q1: Clause E6.2 – If this work requires 2 vehicles for example, is the expectation of the City of Winnipeg to have 1 additional vehicle as a spare?
- A1: **Refer to the Bid Opportunity and specifically E6.2. For example, any quantity of vehicle 10 or less shall have no less than 1 spare Collection Vehicle.**
- Q2: Is the contractor allowed to utilize the spare equipment for other work when it is not required?
- A2: **Refer to the Bid Opportunity and specifically E6.5. The Contractor shall require approval from the Contract Administrator to use the equipment for purpose other than to perform the Work of the Contract.**
- Q3: Can you clarify how many days a week we will be picking up the scheduled and abandoned items in the city? I keep reading on regular garbage collection days, which I thought was done 5 days a week in different areas of the

city each day, but then the map provided only has an area 1 and 2. Are the pickups are only scheduled on certain days, or will pickups be 5 days a week?

Q4: Are you able to tell me how many trucks they have on the road on a daily basis right now to do this work?

A4: The City cannot provide this information.

Q5: How is the material currently being set out for collection at each of the locations (i.e. Residential Dwelling Unit, Charitable Institution, Place of Worship, Commercial Small, Multi-Family Building, Recycling Depot)? (i.e. material is left loose, contained within roll-of bins, contained within front-end bins, etc.)?

A5: Large Items (Bulky Waste) and Abandoned Large Items (Bulky Waste) are not in any type of container. The Material at the Recycling Depot is scattered throughout the Recycling Depot and must be cleaned up as scheduled in the Bid Opportunity .

Q6: Could the City please provide bidders with monthly Historic Quantities for 2018 (so far) for Appendix?

A6: Refer to Appendix A for historic quantities. The City is not prepared to provide historic quantities for 2018.
