
## **KEY NOTES**

- REMOVE AND REINSTALL CEILING/ROOF MOUNTED EQUIPMENT AND DEVICES AS REQUIRED TO ACCOMMODATE ROOF WORKS. SITE CONFIRM REQUIREMENTS WITH ARCHITECTURAL.
- POWER AND DATA FOR TV/DIGITAL SCREEN AT 7' AFFL. COORDINATE POSITION WITH ARCHITECTURAL ELEVATIONS. COORDINATE INSTALLATION OF FLUSH MOUNTED DEVICES WITH
- ARCHITECTURAL MILLWORK/DRAWINGS. CEILING MOUNTED POWER AND DATA FOR PROJECTOR. COORDINATE
- FINAL POSITION OF PROJECTOR WITH OWNER. MOUNT POWER RECEPTACLES IN RELOCATED CCTV CABINET FOR AV
- PROVIDE 1" CONDUIT BEWTEEN CEILING AND WALL JUNCTION BOX FOR HDMI CABLE. PROVIDE HDMI WALL PLATE AT WALL LOCATIONS, AND HDMI CABLE.
- PROVIDE DIRECTION CONNECTION FOR POWER SUPPLY FOR PAGING

## **GENERAL NOTES**

- COORDINATE LOCATION AND MOUNTING HEIGHT OF ELECTRICAL DEVICES IN CRAWLSPACE WITH ALL DISCIPLINES AND TRADES PRIOR TO INSTALLATION.
- WIRING BELOW 2" (50mm) / 50mm (2") ABOVE FLOOR LEVEL INCLUDING BELOW FLOOR LEVEL (SUMP PITS) SHALL BE EXPLOSION PROPERTY OF DATE OF THE PROPERTY OF THE PROPER CONCRETE CURB OR PAD.
- FINAL CONNECTION TO ALL MECHANICAL EQUIPMENT SHALL BE FLEXIBLE. CONFIRM FINAL CIRCUIT BREAKER AND WIRE SIZE WITH MECHANICAL EQUIPMENT SHOP DRAWINGS. ADJUST CIRCUIT BREAKER AND WIRE SIZE AS REQUIRED WITHOUT ADDITIONAL COST TO OWNER.
- HOMERUN ALL NEW VOICE/DATA CATEGORY 6 CABLING BACK TO BASEMENT SYSTEMS CABINET, PROVIDE CONDUITS IN WALLS AND EXPOSED CEILING AREAS, AND J-HOOKS ABOVE T-BAR CEILING AREAS. ALL CATEGORY 6 CABLING SHALL BE FT-6 RATED.
- WIRE ACCESS POINTS (WAP) SHALL BE OWNER FURNISHED AND CONTRACTOR INSTALLED. CONTRACTOR TO PROVIDE 15' FOOT SLACK FOOD ON WAP CABLING AND PROVIDE FEMALE JACKS ON
- HOMERUN ALL PA SPEAKER CABLING TO 4-POST SYSTEMS CABINET IN BASEMENT ELECTRICAL ROOM.


