CONSTRUCTION NOTES

1. CONSTRUCT NEW ASPHALT PAVEMENT OVERLAY TYPE 1A (85mm AVG. THICKNESS)
2. REMOVE EXISTING CONCRETE AND CONSTRUCT NEW 150mm REINFORCED CONCRETE PAVEMENT c/w 85mm ASPHALTIC OVERLAY
3. REPLACE EXISTING CONCRETE LIP CURB (40mm HT. DOWELLED)
4. PLANE EXISTING MOUNTABLE CURB AND CONSTRUCT ALL NEW CONCRETE BARRIER CURB (100mm REVEAL HT. DOWELLED)
5. PLACE PAVEMENT REPAIR FABRIC ON AREAS NEEDED
6. INSTALL NEW CURB AND GUTTER INLET c/w CATCHBASIN 1800mm (SD-0024) AND CONNECT TO EXISTING MAINLINE EXITING LEAD
7. REMOVE EXISTING CATCHBASIN/CATCHPIT AND ABANDON EXISTING LEAD
8. REMOVE AND REINSTALLED PAVING STONES
9. ADJUST EXISTING MANHOLE FRAME TO GRADE
10. ADJUST EXISTING WATER VALVE TO GRADE
11. CONSTRUCT NEW 150mm CONCRETE RETAINING CURB
