Note: 273-2019_Drawing_S2.1.1 is a blown-up drawing of the east end of the facility from 273-2019_Drawing_S2.1.

Add Notes to Drawing S2.1 and S2.1.1:

- .1 The extent of air sealing repairs along the east masonry wall are to follow the angled masonry walls. Refer to partial plan attached. Air sealing detail to be similar to Detail 1/S4.3.
- .2 Note that finished gypsum board ceilings may be present in some locations. Contractor to allow for access to the work areas which could include localized removal and replacement of finished ceilings including painting to match existing.
- .3 Note that the masonry walls in the east portion of the ice rinks have finished gypsum board on the interior face. The gypsum board must be removed to permit installation of the air sealing material to the same height as in the Great Hall. New gypsum board to match existing must be reinstalled and finished to match existing.
