Revise B8.2 B8.2 The Proposal shall include Form H: Hourly Rates, an hourly rate schedule, for the work identified in E9 Additional Work Allowance and for E4 tasks billed at an hourly rate.

- (b) The Proponent shall include a Geotechnical Investigation Allowance of \$150,000.00 in their proposal, which has been included on Form B: Fees and Form P: Person Hours.

- (c) The Additional Work Allowance and Geotechnical Investigation Allowance are to be included in the calculation of Total Fees proposed by the Proponent.

- The Additional Work Allowance and the Geotechnical Investigation Allowance shall only be used with written permission of the Project Manager.
- There will be no fee escalation allowed for yearly adjustments, promotions, etc. (f) Fee scale shall be fixed for the duration of the project.
- A mark-up of a maximum of 10% can be applied by the Proponent on work (g) completed by a subcontractor. The mark-up shall be included in the respective allowance.

Revise B11.5 The Proposal shall include Form H:Hourly Rates for work identified in E4 and E9.

Investigation Allowance proposal must include a resume of not more than two (2) pages so the

City may verify the equivalency of the staff member that is being proposed for use.

Revise: D6.5.1(d) Work under the Geotechnical Allowance must be pre-authorized by the City's Project Manager in

writing. The Consultant shall submit a short work breakdown, including fee proposal, for the City

to authorize prior to the start of work.
