Form B(R1): Revised Spec. Ref. for Items No. 139, 140, 141, 142, 143, 144, 145 and 146.

Revised Description for Items No. 139, 140, 141, 142, 143, 144, 145, 146, 150, 151, 152, 153, 154 and 155.

Deleted Items No. 148 – Supply and placement of (examples include Ketch-All or Quick Catch) mouse traps.

Deleted Items No. 149 - Supply and placement of (examples include Protecta) Rodent Bait Stations.

Page numbering on some forms may be changed as a result.

### PART E - SPECIFICATIONS

Revise: E5.5 to read:

On an "as required" basis, the City may acquire additional traps and services. The pest control services shall include but not be limited to:

- (a) The supply and maintenance of snap traps;
- (b) The supply and maintenance of mechanical rodent traps (examples include Ketch-All or Quick Catch);
- (c) The supply and maintenance of rodent bait stations (examples include Protecta);
- (d) The supply and maintenance of glue boards;
- (e) The supply and maintenance of Konk aerosol mister kits; and
- (f) The supply and maintenance of Konk aerosol mister kit refills.

# Add: E5.5.1 Further to E5.5, the Contractor shall supply, deliver and install the traps, including but not limited to the placement and initial baiting of the trap(s).

Add:	E5.5.2	Further to E5.5, the Contractor shall maintain and service the trap(s) as part of the scheduled Work, including but not limited to cleaning, re-baiting and disposing.
Clarification of E5.5.2:		Only if applicable, any costs associated to the maintenance and service of additional traps acquired by the City, these costs shall be added onto the maintenance fee as listed in Section A, B and C. The fees (if applicable) shall be indicated with Items No. 144, 145, 146, 150 and 151.
Add:	E5.6.1	Further to E5.6, goods shall be delivered on an "as required" basis during the term of the Contract, f.o.b. destination, freight prepaid, to various locations within the City.
Add:	E5.6.2	Goods shall be delivered within three (3) Calendar Day(s) of the placing of an order.
