- Revise: 2.2.1.4.3 to read: Lifts must be equipped with home pockets for saddles to sit flush with floor surface creating an unobstructed floor, free of tripping hazards. Alternatively, lifts must be equipped with home pocket for the rear saddle to sit flush with floor surface creating an unobstructed floor, free of tripping hazards and lifts must be equipped with a front saddle height that will accommodate a drive over clearance of 6 inches (152 mm).
