Revise: B11.4.1 to read: The provided table should include event based activities and will be used to negotiate additional fees for any additional events required as identified in the Public Engagement Strategy described in D6.

Revise: B21.9 to read: Further to B21.1(e), Experience of Project Team Assigned to the Project will be evaluated considering the experience and qualifications of the Key Personnel and Subconsultant personnel on Projects of comparable size and complexity, in accordance with B10.

PART D - SUPPLEMENTAL CONDITIONS

Revise: D6.5.1(a) to read: This phase will commence with the project kick-off meeting and end with a Public Engagement Summary Report to be provided by the Office of Public Engagement (assume approximately twelve week duration for bidding purposes).
