Acrylic selection to be 3-Form Varia Eco Resin ½". Finish Sandstone F-001 both sides, Style Speckle Jest with sanded edges. To be located on each end panel for LS-1 and LS-2, 1" offset from edges, top and base. Mounted to end panel with caps and threaded rods to be quantity of 6 per LS-1 and 4 per LS-2 end panel.
