Add: B10.1.2: Prices stated on Form B: Prices shall not include any costs which may be incurred by the

Contractor with respect to any applicable funding agreement obligations as outlined in

D23. Any such costs shall be determined in accordance with D23.

Revise: B10.2 to read: The quantities listed on Form B: Prices are to be considered approximate only. The City

will use said quantities for the purpose of comparing Bids.

Add: B10.3: The quantities for which payment will be made to the Contractor are to be determined by

the Work actually performed and completed by the Contractor, to be measured as specified in the applicable Specifications. The quantities listed on Form B: Prices are to be considered approximate only. The City will use said quantities for the purpose of

comparing Bids.

Add: B10.4: Payments to Non-Resident Contractors are subject to Non-Resident Withholding Tax

pursuant to the Income Tax Act (Canada).

Add: B10.5: The Bidder shall enter the Total Bid Price from Form B: Prices into the Total Bid Price

field in MERX.

Add: B10.5.1: Bidders are advised that the calculation indicated in B17.4 will prevail over the Total Bid

Price entered in MERX.

Revise: B17.4 to read: Further to B17.1(c), the Total Bid Price shall be the sum of the quantities multiplied by the

unit prices for each item shown on Form B: Prices.

Price entered in MERX.

Add: B18.4: If funding for the Work is provided to the City of Winnipeg by the Government of Manitoba

and/or the Government of Canada, Bidders are advised that the terms of D23 shall immediately take effect upon confirmation of such funding, regardless of when funding is

confirmed.
