PART B – BIDDING PROCEDURES

Revise B2.1 to read:

The Submission Deadline is 12:00 noon Winnipeg time, November 5, 2019.

Revise B8.1 to read:

The Proposal shall include a Fixed Fee for all disciplines, identified and necessary, for each Scope of Service phase of the Project, which include:

- (a) Preliminary Engineering;
- (b) Design and Specification Development;
- (c) Contract Document Preparation
- (d) Procurement Process;
- (e) Non Resident Construction Services; and
- (f) Record Drawings
- Add B8.1.1

The proposal shall include fees based on a Time Basis for resident services. Time Based fees shall be based on providing one full time Inspector during the course of the Work. For proposal purposes these fees should be based on fifty (50) working days to Substantial Performance. The proposed fee should include allowance for

disbursements, including vehicle, electronic communication, etc. The actual working days will be established at time of tender will be with the consultation and concurrence of the Department.

(a) The Time-Based Fee proposal shall include time estimates and hourly billing rates for each person assigned to the project.
