sum price if alternate accommodations can be arranged for the crews.

Add: B10.3 Payments to Non-Resident Contractors are subject to Non-Resident Withholding Tax

pursuant to the Income Tax Act (Canada).

Add: B10.4 The Bidder shall enter the Total Bid Price from Form B: Prices into the Total Bid Price

field in MERX.

Add: B10.5 Bidders are advised that the calculation indicated in B17.5 will prevail over the Total Bid

Price entered in MERX.

Add: B17.4 Further to B17.1c the Total Bid Price shall be the lump sum price shown on Form B:

Prices adjusted, if necessary, as follows:

(a) if the lowest evaluated responsive Bid submitted by a responsible and qualified Bidder is within the budgetary provision for the Work, no adjustment will be made to

the lump sum price bid; or

(b) if the lowest evaluated responsive Bid submitted by a responsible and qualified Bidder exceeds the budgetary provision for the Work, the lump sum prices of all responsive Bids submitted by responsible and qualified Bidders will be adjusted by

progressively deducting separate prices in the order listed in B10.2 until a Total Bid Price within the budgetary provision is achieved.

over the Total Bid Price entered in MERX.
