#### **PART E – SPECIFICATIONS**

- Revise: E1.5.5 (a) to read: Siplast Paradiene 20 TG base sheet or Siplast Paradiene 20 SA on wood deck areas or **Sopralene 180 SP Sopraflash Stick Duo** as alternate or an approved equal in accordance with section B7.
- Revise: E1.5.6 (b) to read: IKO Isotherm 3 **or Sopra Iso Plus** or approved equal in accordance with section B7. Thickness is as indicated on the roof plan.
- Revise: E1.5.8 (a) to read: This shall be Siplast Parafast "C" Adhesive **or Duotack by Soprema** and will be applied to obtain minimum wind uplift as indicated on wind uplift tables attached or approved equal in accordance with section B7.
- Revise: E1.5.9 (a) to read: This is to be Siplast Parapro 123 Flashing Resin **or Alsan flashing by Soprema** or approved equal in accordance with section B7. This is to be used to fill all pitch boxes or as otherwise specified.
- Revise: E1.5.10 (a) to read: Shall be Siplast Paradiene 20 TG base sheet with Siplast Parafor 30 TG cap sheet **or Sopralene Flam 180 / Sopraply Traffic Cap** or approved equal in accordance with B7.
- Revise: E1.5.10 (b) to read: Siplast Materials **or Soprema Materials** shall be used in the following locations;
- (i) Base Sheet – Paradiene 20 SA **or Sopraflash Stick Duo**
  - (ii) Primer – PA 325 **or Elastacol Stick**
  - (iii) Adhesive for the field – PA311 **or Colply Adhesive Trowel Grade**
  - (iv) Flashing cement for flashing – PA 828 **or Colply Adhesive Trowel Grade.**
  - (v) Cap Sheet – Parafor 30LT **or Sopraply Stick Traffic Cap**
