Notwithstanding the foregoing, the Consultant is being engaged by the City for its professional expertise; the Consultant

shall bring to the Project Manager's attention any aspect of the City's Project

Management Manual or templates which the Consultant is of the opinion is not consistent with good industry practice.

QUESTIONS AND ANSWERS

- Q1: Please confirm that the project is for the complete replacement of the fire alarm systems to bring all buildings up to current code.
 - A1: See 166-2021 D5.2
- Q2: The existing campus features a Vipond Notifier system. Is it the intent of Transit to utilize as much of the existing system and devices in the new construction?
 - A2: Utilization of existing system and devices shall ensure code compliance.
- Q3: Has there been any thought put into the potential interconnection of the new fire alarm system to a 24-hour security office (or other)?
 - A3: This interconnection is not required.
- Q4: Can you please confirm that there is no scope for the 600 Brandon Building other then the installation of a roof strobe.
 - A4: Existing interconnection with 600 Brandon must be maintained with any changes to 421 Osborne fire alarm system.
- Q5: As this project is to be costed and constructed in phases as identified by zones. Can Transit advise if the consultant will be responsible for providing construction phasing plans?
