QUESTIONS AND ANSWERS

Q1: On Section B16.1 - Irrevocable Bid, of the Bidding Procedure:

.1 indicates an irrevocable period of 90 days for the submitted bid. Please note that trades can only hold their prices within 15 to 30 days.

On Section D15.4 - Schedule of Work - Commencement, of the Supplemental Conditions:

.4 indicates that The City intends to award this contract by January 06, 2022.

Please clarify which of the above should we consider in our tender.

A1: See revised Form A: Bid/Proposal above.

Q2: What the symbol is at the new hydrant assembly tee connecting to the existing watermain? It is a very bolded and black symbol. Is this supposed to be a new water valve for this service?

A2: The symbol can be disregarded. See revised drawing C1.1R1 above.

Q3: We noticed several piles of lumber, sand, dirt, etc. in the work yard. Will these items be cleaned up prior to construction start or are we to include this clean up in our quote?

A3: Please refer to note 7 on A1.0R1. The City will remove these materials from the site (including lumber, wood chips, sand, etc). The contractor is then to prepare the yard surface for new asphalt or gravel.

Q4: Is the Cat6 voice cable to terminate in a patch panel or BIX Block at the rack? If terminating in a patch panel should there be a 25 pair from the rack to the MTS demarc? Should there be Cat6 patch cables supplied? (Did not mention in spec)

A4: Refer to symbol schedule (data symbol) and specification on E1.0. CAT6 cables are to terminate in E.C. provided patch panel in LAN rack located in Electrical Room 105. Provide 25Pair from LAN rack to MTS demarc within Electrical Room 105. E.C. to provide all required patch cables.

Q5: Is there a base structure available for the paving stone area? Also, what will be the "new gravel" base structure if the pavers are deducted in Separate Price #1? What will be the "new gravel" base structure if the asphalt is deducted in Separate Price #2?

A5: A concrete paver structure to has been added to drawing C2.1-R1. The gravel surface structure for both separate price items No. 1 and 2 would be the gravel surface structure already shown on the civil drawings. The asphalt and concrete paver structures would not be modified, but would instead be replaced by the gravel surface structure.

Q6: Please clarify the rebar detail for the P7 pile. It is not shown on the drawings. The rebar details only go up to P6, not P7.

A6: Reinforcing steel for pile P7 to be 10-15M vertical, 10M rings at 1200mm on-centre, with 3-10M rings top at 150mm on-centre. Refer to revised structural drawings above.
