PART B – BIDDING PROCEDURES

Revise: B3.1 to read: The Submission Deadline is 12:00 noon Winnipeg time, **June 22, 2021**.

Revise: B5.5 to read: The preferred proponent for the Headworks Project, Red River Solutions, was approved at the May 27, 2021 City Council meeting. **A final draft version of the Independent Certifier Agreement is included in Attachment 1. For convenience a blackline comparison of Version 4.0 to the final draft version is included in Attachment 3.**

Revise: B12.3(a) to read: The total amount of milestone certificates to be issued in the executed DBA will be **104**;

Add: B28.2 Updated versions of DBA Schedule 2 – Design Builder’s Project Schedule and DBA Schedule 9 – Milestone Criteria and Milestone Payments, are available by request to the City’s Project Manager after completion of a Non-Disclosure Agreement included in Attachment 2. These documents will be released at the sole discretion of the City to bona fide Proponents.

Add: B28.2.1 A Proponent only needs to sign the Non-Disclosure Agreement once. However, the Proponent will need to request the documents referred to in B28.2 directly from the City’s Project Manager in addition to the documents referred to in B28.1 (Addendum #3).

QUESTIONS AND ANSWERS

Q1: Why are there two definitions of 'Project'?

A1: RFP 64-2021 uses 'Project' when referring to the Independent Certifier's scope of work. The Design Build Agreement uses 'Project' when referring to the Design Build Agreement's scope of work. Once the Independent Certifier Agreement is executed, the definition of 'Project' will refer to the Design Build Agreement and 'Certification Services' will refer to the Independent Certifier's scope of work.
