E21. CAST IN PLACE CONCRETE PLAY EDGING

- E21.1 General Description
- E21.1.1 This section shall cover the supply and installation of cast in place concrete play edging as per the Drawings. It shall amend and supplement the most up-to-date version of City of Winnipeg Standard Construction Specifications section 3310 and as per SCD-643 and details in Drawings.
- E21.2 Materials
- E21.2.1 Concrete shall be Type 1 as per the most up-to-date version of City of Winnipeg Standard Construction Specifications section 3310 and shall adhere to the dimensions on the Drawings.
- E21.2.2 Granular base shall be 19mm diameter crushed limestone.
- E21.2.3 Reinforcing steel for play edging shall be 10m with 10m ties at 600 mm O.C.
- E21.3 Construction Methods
- E21.3.1 Layout is to be established on Site, after excavation and grading operations and reviewed by Contract Administrator prior to formwork being completed.
 - (a) Contractor is to confirm and warrant that play equipment and swings (complete with required safety surfacing zones) will fit within curbs as laid out on Site.
- E21.3.2 Granular base, formwork and reinforcing are to be reviewed on Site by the Contract Administrator prior to pouring of concrete.
- E21.3.3 Concrete is to be trowel finish. All exposed edges are to be bull nose as shown on the Drawings. Front, top and back of curb are to be finished.
- E21.3.4 Concrete edging shall have saw cut control joints at 1.5m intervals.
- E21.4 Method of Measurement and Basis of Payment
- E21.4.1 Method of Measurement shall be as follows:
 - (a) Concrete edging will be measured on a Linear Metre basis for:
 - (i) "Supply & install double tier timber edging OR CIP concrete edging" on Form B-R2: Prices.
- E21.5 Basis of Payment Shall be as follows:
- E21.5.1 Concrete edging will be paid for at the Contract Unit Prices. The amount to be paid for shall be the total number of units, as indicated on Form B: Prices. This price shall be full payment for supplying all labour, equipment and materials, and performing all operations herein described and all other items incidental to the Work and as accepted by the Contract Administrator.
- E21.5.2 This payment shall be understood to include all concrete, excavation, base, reinforcing, compaction, placement and finishing.
