PART D – SUPPLEMENTAL CONDITIONS

Revise: D29.5 to read:

D29.5 The Fuel Factor (FF) rates will be set as follows:

- (a) The Fuel Factor rate shall be set at 2.7% of the monetary value for Section A identified on Form B: Prices related to Surface Works.
- (b) The Fuel Factor rate will be set at 1.2% of the monetary value for Section B identified on Form B: Prices related to Water and Waste Works.
- (c) The Fuel Factor will not apply to the following sections identified on Form B: Prices related to:
 - (a) Section C: Street Light Renewal Works;
 - (b) Section D: Mobilization/Demobilization.

Page numbering on some forms may be changed as a result.

PART E – SPECIFICATIONS

Revise: E19.1 b) to read:

- (b) In addition, the Contractor shall refer to Appendix G and note the requirements for locating all gas mains within the site and determining depth of cover prior to starting the Work, specifically:
 - (i) Absolutely no Work, including concrete cutting or pavement breaking, may occur over a natural gas pipeline (regardless of size) until depth of cover is determined by the Contractor by soft-dig methods.
 - (ii) Select shallow pavement removal shall be permitted only for the purpose of providing access for soft-digging to determine depth of cover.
 - (iii) Provide the station, offset, and depth of cover from existing ground to the Contract Administrator in tabular form.

QUESTIONS AND ANSWERS

Q1: Can concrete pipe be used as an alternative product for the SDR26 PVC pipes and fittings?

A1: Yes, concrete pipes and fittings can be used as an alternate product for the SDR 26 PVC pipe and fittings, only if the pipes are suitable for trenchless installation and both pipes and fittings are rated as a Class V Concrete Products.
