Form B(R2): Add Items No. 3(a) and 3(b).

#### PART B – BIDDING PROCEDURES

Revise: B2.1 to read: B2.1 The Submission Deadline is 12:00 noon Winnipeg time, February 23, 2022.

#### PART D – SUPPLEMENTAL CONDITIONS

Revise: D19.1 to read: The Contractor shall achieve Substantial Performance within thirty (30) Working Days of the commencement of the Work as specified in D16, or by August 15, 2022, whichever comes first.

## PART E - SPECIFICATIONS

Add: E11.5.2(a)(iv) In lieu of blast cleaning, the West Tunnel Shaft pipe penetrations may be prepared to bare metal by approved mechanical means to SSPC SP11. Revise: E12.2.1(b)(i) to read: The existing feeder main crossing was constructed with an interior coal tar epoxy lining. The Contractor shall select appropriate cleaning methods and undertake reasonable efforts to preserve the existing interior pipe coatings wherever it is possible and practical to do so. Revise: E12.7.1(a) to read: Pipeline Cleaning will be paid on a daily basis with an hourly overtime rate, at the respective unit rates for "600 mm Feeder Main Cleaning and Lining Preparation Work" as listed in Form B: Prices. Add: E12.7.1(d): Time measured will be based on on-site availability of the Contractor's crews, from the time crews are present on site until work is complete and site is secured for the shift, as certified by the Contract Administrator.

Add	E12.7.1(e):	Daily Cleaning Rate will apply for each day of cleaning activity, up to a maximum of 10 hours. Hourly overtime rate will apply for each hour or measurable portion thereof in excess of the daily maximum of 10 hours per day.
Add	E12.7.1(f):	The supply of pigs and other consumable materials for pipeline cleaning will be considered incidental to "600 mm Feeder Main Cleaning and Lining Preparation Work" and will not be measured for payment.
Add	E12.7.1(g):	Flushing of pipelines for the purposes of debris removal will be considered incidental to "600 mm Feeder Main Cleaning and Lining Preparation Work" and will not be measured for payment.
