ALL PRIVATE WALKWAYS TO BE ADJUSTED TO NEW SIDEWALK OR TOP OF CURB ELEVATION, AS REQUIRED.

ADJUST MH FRAMES, CB RIMS, CURB INLETS, AND VALVES TO NEW GRADES, AS REQUIRED.
MODIFIED BARRIER CURB TO BE CONSTRUCTED AT ALL INTERSECTION RADII AND BACK LANE RADII. LAMP STANDARDS, HYDRO POLES, AND ANCHORS THAT REQUIRE TEMPORARY SUPPORT, REMOVAL OR REPLACEMENT, TO BE DONE SO AT THE EXPENSE OF THE CONTRACTOR AS NECESSARY.

CONTRACTORS TO TAKE PRECAUTIONARY STEPS TO PROTECT EXISTING TREES WITHIN THE LIMITS OF CONSTRUCTION FROM DAMAGE FROM CONSTRUCTION ACTIVITIES AS OUTLINED IN THE SPECIFICATIONS.

ALL BOULEVARDS TO BE SODDED UNLESS OTHERWISE NOTED. 10. FULL AND PARTIAL DEPTH JOINT REPAIRS, AND SLAB RENEWALS TO BE FINALIZED IN THE FIELD PRIOR TO CONSTRUCTION. THE REPAIRS IDENTIFIED ON THIS DRAWING ARE FOR TENDER PURPOSE ONLY.
