Add: D3.2(h) The City of Winnipeg will complete all roofing work and penetrations. Proponents must coordinate their work directly with both the City of Winnipeg and the Roofing contractor.

Add: Quantum CUSTOM to the acceptable manufacturers of the Wired Shelving Tag-S. Ensure height and finish of shelves as per equipment schedule.

Add: Kelvinator Commercial (KCHRI27R1DFE) to the acceptable manufacturers of the Freezer Tag-I.

Refer to: 432-2023 _Drawing_A4.1-R4. Hardware Groups, Hardware Group 1.

Add: Besam - Model SW200i to the acceptable manufacturer of the Automatic Door Operator.

Mechanical

Refer to: 432-2023 _Drawing_M1-R2, Grille and Diffuser Schedule.

Add: Nailor and Titus to the acceptable manufacturer of the specified Grilles and Diffusers S-1 and R-1.

Add: Cook and PennBarry to the acceptable manufacturer of the specified kitchen exhaust fan EF-5.

Add: Nailor to the acceptable manufacturer of specified fire dampers.

QUESTIONS AND ANSWERS

Q1: Where is parking allowed?

A1: Contractors can park close to the gym of the building as long as access for fire vehicles is maintained.

Q2: Where can we have a demolition bin?

A2: A demo bin will be allowed on site, close to the building.

Q3: Can we work after hours?

A3: Yes - there are staff in the facility until 9pm, so access after that time would need to be coordinated with Central Control.

Q4: D-112A is spec'd fire rated yet the schedule has 1/4" tempered glass?

A4: Refer to 432-2023 _Drawing_A4.1-R4. Please review the Door & Window Schedule. Remarks in the 'Rating' **column** do not indicate fire protection rating for the door or frame. Rather, structural fire protection is to be provided per drawing detail 1/A4.1.

Q5: Also, do you have the function, trim and finish for the Sargent Mortise Lock?

A5: Regarding the mortise lock, per Note 1 on the Door & Window Schedule, we are salvaging the existing locksets on both doors requiring Hardware Group 1 (D-112A and D-110), so the mortise lock is not expected to be required, just the new lever set, with a brushed silver finish or similar. However, if the reuse of the existing locksets proves unfeasible, we'll issue a PCN at that time to provide a spec for the mortise lock.
