### DESCRIPTION

E29.1 Further to CW 2130, this specification covers the supply and installation of sewer service outlet restrictors.

### MATERIALS AND CONSTRUCTION METHODS

E29.2 Restrictors are to be installed as per the Contract Drawings and SD-025B.

### MEASUREMENT AND PAYMENT

E29.3 Supply and Installation of sewer service restrictors will be measure for each location and paid for at the Contract Unit Price for “Supply and Install Sewer Service Outlet Restrictor” as per the corresponding reduced diameter. The units will be paid for each unit supplied and placed in accordance with this Specification and as measured and accepted by the Contract Administrator.
