PART B – BIDDING PROCEDURES

Revise: B10.6 to read: The Proponent shall complete Form B: Section A – Local tab and enter pricing for the complete functioning of the proposed systems as per Section E2:

- (i) All configurations, peripherals/ accessories, installation and/or professional support and training.
- (ii) Monthly subscription, maintenance and support.

Revise: B10.7 to read: The Proponent shall complete Form B: Section A – Remote tab and enter pricing for the complete functioning of the proposed systems as per Section E2:

- (i) All configurations, peripherals/ accessories, installation and/or professional support and training.
- (ii) Monthly subscription, maintenance and support.

Revise: B10.8 to read: The Proponent shall provide detailed pricing for all the items included in the proposed configurations listed as per Section E2.

PART E – APPLICABLE SPECIFICATIONS

Revise E2.6 to read: Pricing for configurations shall include any one-time costs and monthly costs as per Form B pricing.

QUESTIONS AND ANSWERS

Q1: In Section D2.2 you indicate within each Data Centre there is 1 IBM TS4500 Tape Library. Can you indicate how much floor space this library will require? Also, is the floor space for this included in the requirement for A2 - R5?

A1: Section D2.2 is for informational purposes only.

Q2: In Part D 2.1 indicates that the City of Winnipeg would like to divest itself of Data Centers with some applications moving to SaaS, PaaS, IaaS or a colocation data centre. This suggests that the current City of Winnipeg Colocation requirements should contract from their current state. In Part D 2.2 (a) and (b) includes a summary of the current server, storage equipment plus D2.3 Summary of Network equipment. This equipment should easily fit within 3 to 4 Cabinets per site. However, Form N Requirements A2 - R5 indicates the City would like to contract for a private cage to accommodate 10 cabinets with the option to expand to accommodate an additional 14 cabinets, for a total of 24 cabinets. Can you please confirm the private cage space, and the number of cabinets you require in the new local and remote data centres, initially and long term?
