### **PART E – SPECIFICATIONS**

- Revise: E1.1 to read: **AS-BUILT drawings are required for all Public Works construction projects** except TBOs or Mill & Fills, unless specifically declined, in writing, by the Consultant Contract Administrator.
- Revise: E1.1.1 to read: As-built drawing submissions are required for any addition to infrastructure inventory such as new streets, street widenings and/or realignments, new or realigned multi-use paths, sidewalks, or sidewalk segments, Neighbourhood Greenway, Transit works, or traffic calming.
- Add: E1.1.2 As-built drawing submissions are required for the TBO or Mill & Fill portions of renewal projects (reconstructions or rehabilitations) that include a TBO or Mill & Fill within their (continuous) limits.
- Add: E1.1.3 Where as-built drawings are not required, a sketch must be provided including any new or relocated sidewalks, or sidewalk extensions, curb ramps, new or removed approaches, adjusted curb inlets, relocated lighting, transit stops, and/or any other modifications, on existing streets or intersection improvements.

**General Notes:**

*The "Additional Information" provided within the following tables relative to specific Project Packages and/or Project Locations contain specific information or issues, known to exist on Site at the time of issuance of this Request for Proposal. *The specific utility and agency coordination identified below notwithstanding, the successful Consultant(s) will be required to investigate and coordinate any utility requirements of the Project.*

*Construction adjacent to schools will be avoided during the school year where possible, and otherwise coordinated with the respective school division.*

*Any project locations with railway crossings within or adjacent to their limits must have work coordinated with the respective rail authority.*
