- Q2: Rooms 1M:02 and 1M:03 call for an EFP floor finish. This is not in the legend. What kind of material is this?A2: EFP is an Epoxy Floor Paint for service rooms, refer also to Project Manual section 09 00 00.
- Q3: Panelboard M2C and M2D are the wrong size. They are 225A Panels fed by 400A breakers. Please Advise.A3: Refer to drawings in this addendum.
