PART B – BIDDING PROCEDURES

Revise: B2.1 to read: The Submission Deadline is 12:00 noon Winnipeg time, March 28, 2024.

Add: B10.2 (iii) Separate Price to be deducted from Total Bid Price – Item No. 3 shall be the amount deducted from the Total Bid Price if the Supply and Install Hydration Station is deleted in accordance with B24.4(b).

Revise: B24.4 (b) to read:
if the lowest evaluated responsive Proposal submitted by a responsible and qualified Proponent exceeds the budgetary provision for the Work, the Total Bid Prices of all responsive Proposals submitted by responsible and qualified Proponents will be adjusted by progressively deducting items 1, 2, and 3 from 'Separate Prices to be deducted from Total Bid Price' noted on Form B: Prices in the order listed here until a Total Bid Price within budgetary provision is achieved.

PART E – SPECIFICATIONS

Revise: E13.1 to read:

This section shall cover the removal of asphalt, sand, gravel, topsoil concrete and sod, and other items where scheduled for removal including the wading pool. It shall also cover any other demolition and removal necessary to construct the project which may be considered incidental to other items of Work. Removal of

the washroom building down to the pad is by others. The removal of the building pad and associated underground services including sewer and water lines is to be included in this Contract.

Add: E16.2 (l) Sequencing of fixture operation is to ensure a maximum peak usage of between 40 and 60 US gallons per minute.

The following is a summary of changes incorporated in the replacement Drawings:

1. Replace note "Hydration station by others. Coordinate station drain. Riser to be installed as required" with "Hydration station. See L-1 & L-2. Coordinate hydration station drain. Riser to be installed as required. INV NE: 229.88"
2. Abandonment of the existing bathroom WWS.
3. Abandonment of the existing wading pool drain and remove of the existing manhole (subject to UGS approval).
4. Installation of new spray pad drain and connection to combined sewer.
5. Revised pre-development and post-development wastewater flow calculations.
