#### **PART B – BIDDING PROCEDURES**

Revise: B8.1 to read:

B8.1 The Proposal shall include a Fixed Fee for all disciplines and/or phases identified in D6 Scope of Services.

- (a) A minimum of 10% of the project budget should be directed to Indigenous Rightsholders (First Nations, Inuit and/or Red River Métis (Métis) peoples) Team member(s) or an Indigenous (First Nations, Métis, and/or Inuit)-owned firms, with local knowledge and connections.
  - (i) Evaluation will be based on the following criteria:
    - (i) Meets with requirement of 10% of the project budget allocation;
    - (ii) Proponents demonstrate representation from more than one Rightsholder group. It is preferred that budget is directed to First Nations, Métis **and** Inuit members or firms; and
    - (iii) Proponents demonstrate more than 10% of the budget is directed to Indigenous Rightsholders.
  - (ii) Along with verification, identified through the Social Procurement questionnaire, Appendix F, third-party verification should encompass either validation of government issued First Nation, Inuit, and/or Métis documentation or affirmation from the First Nations, Inuit and/or Métis government.

Revise: B9.3 to read:

B9.3 Team should include First Nations, Métis, and/or Inuit representation with knowledge of the local communities, nations, ecology and Rightsholders. The Proponent is encouraged to include representation from more than one Rightsholder group.
