(a) **ONE** section including the information requested in C5, C6, and C7 (firm information, personnel information, TYPICAL project delivery information). This section is restricted to the page limit provided in C2.2(a), in total; and

(b) ONE, PROJECT-SPECIFIC SECTION, FOR EACH PROJECT for which you wish to be considered, with the information requested in C10. These sections are restricted to the page limit provided in C2.2(b), for each project.

Revise: C2.2 to read:

The Qualification Submission should be submitted in a PDF format; with a font of not less than 11 pt Arial on 8.5"x11" pages; margins not less than 0.75"; line-spacing not less than single; and:

- (a) should be no more than **six (6) pages** in length for any supplemental information for C5 and/or C6 not covered by Form Q, and Project Planning and Delivery (C7), and:
- (b) **three (3) additional pages** permitted for the summary of the Project Understanding Technical Approach (Section D-2) for **each project** selected in C9
- (c) the above page limits are exclusive of the required form(s).
 - (i) If used, the table in C9.2 (project preference) can be considered a form.

Submissions should include names of **all eligible key personnel** expected to be available for 2025 capital roadway projects. "Key personnel" may include any subject matter experts that may be required for any of the projects.

- (c) **minimum three (3), maximum nine (9)** projects, comparable in scope, size and complexity, in which the individual did work and/or played a role comparable to any job function listed in C6.3(a), including the following information:
 - (i) project description;
 - (ii) any additional information regarding their project contribution that may be relevant;
 - (iii) project role; and
 - (iv) project owner.

Revise: C7.2 to read:

The Submission should outline and describe all of the key roles or job functions through **all phases** of delivery of projects such as those in C3.1.

- (a) describe each job function/role for an individual or group of individuals, including:
 - (i) project role;
 - (ii) description complete with responsibilities and tasks;
 - (iii) typical percentage dedication to a project such as those in C3.1(a), (b), or (c).

Revise: C7.3 to read:

The Submission should include a suggested organizational chart for typical projects which identifies the project roles as defined in C7.2.

Revise: C10.1 to read:

Further to C9.1, for each project indicated, the Proponent should expand on the general information provided in C7, for each of the specific locations and/or circumstances of the preferred project(s) indicated in C9.1.

Add: C10.1.2

Further to C10.1, Proponents are reminded that any information regarding fees, rates, work plan or schedule is NOT required in the Qualification Submission.
