		DECRIPTION
	E21.1	This specification describes the layout and quality assurance to be performed by the Contract Administrator and requirements by the Contractor.
		CONSTRUCTION LAYOUT AND QUALITY ASSURANCE
	E21.2	The Contractor shall provide five (5) working days notice prior to mobilization to any corridor to allow for temporary lane closure submittals. The Contractor shall again notify the Contract Administrator two (2) hours prior to actual mobilization.
	E21.2.1	Directional closures and also long-term closures are not permitted unless approved in writing by the Contract Administrator. Where only one lane is present and a median is present, flag-persons will be required. Where only one lane is present and a median is present, the Contractor shall develop a construction access plan in consultation with the Contract Administrator.
	E21.2.2	Once notice is provided for mobilization to a respective corridor, the Contract Administrator will provide layout and grades.
	E21.3	The Contractor shall provide twenty-four (24) hours notice, or more, prior to placement of concrete. During this time the Contract Administrator shall inspect the compaction of leveling course, and the form work. The Contractor is responsible for adjusting the form work as identified during the inspection. This notice also allows time to arrange for material testing.
	E21.4	The Contractor shall not place concrete unless the Contract Administrator is present to provide inspection services.
	E21.5	The Contractor shall notify the Contract Administrator once a corridor restoration has been completed to arrange for an inspection to approve the site clean up and acceptance of the sod.
