PART E - SPECIFICATIONS

Revise: E16.1(a) to read: This Specification supplements and amends City of Winnipeg Standard Construction Specification CW 2130 Gravity Sewers and shall cover the installation of large diameter manholes and **new**

manholes on existing pipes.

Add: E16.5(b) to read: (b) New Manhole on Existing Sewer

Construction of new manholes on existing sewers shall be measured on a vertical metre basis for each diameter of "New Manhole on Existing Sewer" listed on Form B: Prices by base diameter, base height, and associated riser sections. The price shall include, but not be limited to, excavation, shoring, backfill, connections to existing pipes (including new pipes to connect to existing pipes), reducers, adjusting rings, frames and covers, benching, rungs, couplings and all appurtenances, and miscellaneous metals and materials.

QUESTIONS AND ANSWERS

Q1: On sheet LD-13000 there appear to be typos for the 300 mm LDS work south of Carter Avenue. Should the regraded pipe actually be 300 mm and not 250 mm? How do we get paid for the connection to the existing 300 mm pipe?

A1: Yes, the regraded pipe should be 300 mm and is already included in the Form B: A.8 b) i) quantities for 300 mm pipe. The connection will be paid out in a new line item in the Form B (A.21 a) Connection to Ex. Catch Basin Lead).
