## **QUESTIONS AND ANSWERS**

Q1: Definitions – D5.1 c) Can the City please confirm what non-core modules consist of? Transportation Management is mentioned, but does non-core also include Civic Address Management, Cadastral Mapping, Assessment and Taxation, Water and Sewer Network Management and Parks, Green Spaces and Forestry?

A1: Non-core modules are software extensions typically installed separately from the contractors' foundation GIS software (ArcGIS Pro Desktop or GeoMedia Professional Desktop would be considered a Core GIS).

Non-core modules could include the following but may also be included within a contractor's core GIS software:

- Transportation Management software for LRS maintenance
- Water and Sewer Network Management
- Advanced Incident Analysis (finding hotspots and repeat incidence)
- Civic Address Management
- Cadastral Mapping
- Transaction Management
- Advanced Raster Grid analysis
- Advanced 3D viewing/analysis
- Mobile GIS software

The City does not currently use non-core modules for Assessment, Parks, Forestry or Greenspace as the current contractor's core software manages these. The City is not asking for a separate module (non-core extension) to manage the Assessment, Parks, Forestry, or Greenspace Data.

Q2: "Assessment & Taxation" are listed as operational with the Hexagon GeoMedia Professional GIS solution. Given the City of Winnipeg released RFP #486-2023 for CAMA Solution, can the City clarify the requirement for the Key Personnel as part of RFP #495-2024? Is integration with the newly awarded CAMA solution required?

If so, are you able to provide the current CAMA Solution.

A2: Integration with the new or current CAMA solution is not a part of this Tender.

Q3: Item E5.2 refers to the required training of the core GIS desktop product for 200 users. Is the City open to a requirements assessment to ensure the appropriate training is applied to the necessary users/user groups?

A3: The City is open to requirements assessment to ensure the appropriate training is applied to the applicable Department branches and groups.
