changes incorporated in the replacement Form B: Prices:

Form B(R1): Item No. 1: Removed the quantity from the column Number of Tow Trucks

Item No. 2: Removed the quantity from the column Number of Tow Trucks

The bidder should enter the Number of Tow Trucks in their fleet. An amount is calculated

based on the Price per Hour per Tow Truck and the Number of Tow Trucks.

PART B – BIDDING PROCEDURES

Revise: B6.8 to Read: If the Contract Administrator approves a substitute as an "approved alternative", any

Bidder bidding that approved alternative may base their **Bid Price** upon the specified item but may also indicate an alternative price based upon the approved alternative. Such alternatives will be evaluated in

accordance with B16.

Revise: B6.9 to Read: No later claim by the Contractor for an addition to the **Bid Price** because of any other

changes in the Work necessitated by the use of an approved equal or an approved alternative will be

considered.

Revise: B13.2 to Read: Following the Submission Deadline, the names of the Bidders and their **Bid Prices**

(unevaluated and pending review and verification of conformance with requirements) will be available on

Revise: B16.4 to Read: Further to B16.1(c), the **Bid Price** shall be the sum of the quantities multiplied by the unit

prices for each item shown on Form B: Prices.

PART D - SUPPLEMENTAL CONDITIONS

Add: D4.1 (f) "Curb weight" means the weight of a vehicle without passengers or cargo but with all

standard equipment and necessary operating consumables like fuel and oil.

Add: D4.1 (g) "Tow dolly " means a two wheeled trailer designed to transport a vehicle by lifting its front

wheels off the ground while the rear wheels remain on the road.

Add: D4.1 (h) "Safety chains" means chains used as a secondary connection between a towed vehicle

and the towing vehicle.

Revise: D16.2 to Read: The City will assess the productivity of towing services on an hourly basis as

towing services are underway. The evaluation will consider factors such as numbers of tows completed and time gaps between tows. A tow truck is expected to complete six (6) tows in an hour during a Street Cleaning operation and four (4) tows in an hour during Snow Clearing

operation.

PART E - SPECIFICATIONS

Revise: E3.1 to Read: The Contractor shall at all times have available tow trucks equipped with a fully

functional hydraulic lift system, tow dolly and safety chains that meet the following requirements:

Revise: E3.1 (a) to Read: Capable of towing a vehicle with a curb weight of 1,900 kg up to 3,700 kg; and

Revise: E3.1 (b) to Read: Comply with all City By-Laws and Provincial regulations and acts when delivering

vehicle towing services.
