submerged conditions.

Revise: 2.5.5.3.3 to read: Use rigid style couplings in all other applications. In sizes through 300 mm, housing key

shall engage the bottom of the groove. Acceptable products are Victaulic Style 89,

Victaulic Style 107 and W89 (DI) or 489 (SS) or approved equals.

# **QUESTIONS AND ANSWERS**

Our excavation subcontractor is asking if it is determined upon testing of the groundwater that it is in fact, contaminated and required to be pumped into a holding tank and taken offsite as mentioned in the remediation plan appendix section 4.4 would that be captured in the cash allowance? Currently, it says the cash allowance is for asbestos and roof inspections, which we feel the Roofing portion of it may be an error please advise.

A1 If water from excavation is found to be contaminated as outlined in Appendix N – Remediation Plan, the Contractor can request to use the Extra Work Allowance to cover the cost of disposal of contaminated water. The Extra Work Allowance is not to be used for pumping, storage or testing of water or the mitigations to minimize surface water infiltration into the excavation.

Q2 09 91 10 – Factory Applied Coatings – Are there specific equipment or materials this specification applies to?

A2 This is a general specification. As stated in the specification, the coatings are required on all process and mechanical equipment, vessels and pipes unless specifically deleted.

Q3 09 91 13 – Field applied maintenance and corrosion protection coatings. Notes to refer to drawings and schedule for types and location. Can you advise where those drawings and schedules are located?

A3 This is a general specification. The schedules are included within the specification.

- Q4 Just reviewing Form B in addendum #11, all the changes in quantities from addendum #8 are reverted back to the initial values. Addendum #11 lists only the "lump sum" unit change for B14 as changed. Please confirm the change in quantities back to the original values is correct?
- A4 No, the change in quantities in Addendum 8 should be followed. Please refer to updated 721-2024\_Addendum\_12\_Form\_B-Prices included in Addendum 12.
- Q5 In Section 40 05 13.01, Page 4 of 6 AECOM has specified Neoprene Gaskets for Grooved Couplings. Can we use a Nitrile Gasket as follows in lieu of the Neoprene?

- Q6 In Section 40 05 15, Page 3 of 8 clause 2.5.5.3.1 can we add Victaulic Style W07 as equals?
- Yes, please refer to revision to Process Pipe Joints and Equipment Connections Section 40 05 15 clause 2.5.5.3.1 adding Victaulic Style W07 included in Addendum 12.
- Q7 In Section 40 05 15, Page 3 of 8 clause 2.5.5.3.3 can we add Victaulic Style 107 as equals?
- A7 Yes, please refer to revision to Process Pipe Joints and Equipment Connections Section 40 05 15 clause 2.5.5.3.3 adding Victaulic Style 107 included in Addendum 12.
- According to supplier, the performance specification for Section 07 72 33 Roof Hatches is not able to be met. Does it need to be bi-parting doors, or does it need to be fully insulated or enhanced (i.e. thermally broken)? See attached regarding insulation and the weight of the item.
- A8 Please refer to updated Section 07 72 33 revised above in NMS Specifications of Addendum 12. Bi-parting doors no longer required. Basis of design is Bilco F-50TB.
- Q9 In regard to Section 23 73 11 could you please review the following products as equivalent products? Air Handling Unit Air Wise, Tamco Damper Ruskin, Tamco Damper Ventex/Alumavent.
- A9 Yes, please refer to updated Section 23 73 11 Air Handling and Condensing Units Split section 2.1.1 and 2.1.12 which adds Acceptable Manufacturers.

Q10 In regard to Section 23 74 00 could you please review the following products as equivalent products? Make-up Air Unit - Air Wise, Tamco Damper - Ruskin, Tamco Damper -Ventex/Alumavent. A10 Yes, please refer to updated Section 23 74 00 Packaged Make-Up Air Units section 2.1 which updates the Acceptable Manufacturers including the products listed in Q10. Q11 In regard to Section 23 21 14 could you please review the following products as equivalent products? Armstrong Air Separator - Wessels A11 Yes, please refer to updated Section 23 21 14 Hydronic Specialities section 2.3.1 which updates the Acceptable Manufacturers including Armstrong Air Separator - Wessels Q12 We are looking to get an approval for the Kawneer 6500 series in lieu of the Alumicor 1990. I have attached a product data brochure for you to peruse and let me know if the consultants will allow us to price this product. A12 After a review of this request for equal: Approved, appears to meet the design criteria of the specifications. Please refer to Section 08 51 13 Aluminum Windows addition of clause: 2.1.1.2.2 Q13 There are existing trees to be removed for the scum dewatering building. Will these be removed prior to April 30th, to avoid bird nesting? Is the natural vegetation primarily limited to the trees?. A13 Yes, the natural vegetation is primarily limited to the trees. The City is working to remove the trees in the construction area prior to April 30th, but this Work remains as a requirement of the Contract and should be including in bid prices. If the City is able to remove the trees prior to award, a credit will be requested to remove from the Contractor's scope of work. Q14 01 56 00 - 1.3 mentions 2x4 framed enclosure for fencing. Can you please confirm that a standard 6' high construction metal wire panel fence is acceptable? A14 Clause 1.3 is referring to hoarding not fencing, therefore metal wire panel fencing would not be acceptable. Q15 Does the commissioning agent mentioned in the spec need to be a third-party agent or can it be the contractor's staff (meeting the experience requirement)? A15 The Commissioning Agent does not need to be a third-party agent.
