QUESTIONS & ANSWERS

Architectural

- Q1: Could you please confirm the value of the existing building in order to obtain a quote for wrap-up liability coverage?
- A1: The existing building is currently insured for \$11m.

Electrical

- Q1: Provide Cat. No for type 8 lighting.
- A1: The catalog number is listed in the luminaire under description for clarification type 8 shall be vista lighting CP 4069.
- Q2: Are the half-shaded voice/ data symbols with '2D' just 2 data or 2 data and 1 voice?
- A2: All voice data symbols shall be completed with 2 CAT6 FT6 Data cables.
- Q3: Is the intent of the lighting control meant to wireless throughout?
- A3: The intent is to have wireless controls throughout.
- Q4: Panel A is said to be demolished and not relocated but the new lights are to be fed from Panel A. Where are the new lights to be fed from if panel A is to be demolished?
- A4: As per previous addendum PNL A and new PNL PL are the same.
- Q5: Light type '6' on Drawing EL2.1, is just floating in the centre what length is the actual fixture to be.
- A5: Refer to drawing EL2.1, Type 6 luminaire is mounted with in desk mill work. Provide minimum 25 ft of luminaire complete with manufacturers recommended control and drivers. Confirm final length with mill work shop drawing prior to ordering. Control switch for luminaire shall be located within millwork.
