#### **PART B – BIDDING PROCEDURES**

Revise: B2.1 to read: The Submission Deadline is 4:00 p.m. Winnipeg time, **April 5, 2024.**

#### **PART D – SUPPLEMENTAL CONDITIONS**

Revise: D2.2 (a) to read: As-required Wash: shall be performed on an “as-required” basis for the period between April 1, 2024 and **November 30, 2024** as per E2.2

Revise: D2.3.1 to read: The type and quantity of Work to be performed under this Contract shall be as authorized from time to time by the Contract Administrator and/or Users. **The Users will be specified at the pre-commencement meeting.**

Clarification of D13.2

D13.2 The timeframes will commence once the Contractor starts washing.

**The User will, within reason, have the Equipment ready at the designated Site for the start of the Wash.**

#### **QUESTIONS AND ANSWERS**

Q1: Is there a designated area where we will be cleaning equipment on site?

**A1: There are designated areas of work. Refer to E3.1.**

Q2: Is there an indoor area that is typically used during the winter months for cleaning or is it all specifically outdoors? We assume that there is not but want to verify.

**A2: Work is all completed outdoors. Refer to E3.1.**

Q3: When we come to clean, will all of the vehicles and equipment be lined up and ready to go typically? Or will the equipment be actively used in which we will be waiting between machine? Can we expect that when we are called in to do a cleaning, the majority of the equipment listed is needed to be cleaned?

**A3: The User will, within reason, have the Equipment ready at the designated Site for the start of the Wash. Refer to E2.4 (Addendum 1) for typical hours per site per month.**

Q4: When we are asked to come out, is it typical to be sent to multiple locations that day, or typically one location only?

**A4: Overlap of locations is not typical. Refer to E2.4 (Addendum 1) for wash frequencies.**

Q5: Is the person who requests our services always the same person? Do they oversee all of the sites?

**A5: Refer to D2.3.1 Addendum 2.**

Q6: Are there any standard dates that equipment is expected to be cleaned, like a shut down period that is regularly scheduled or something similar? Or is it just as needed only? **Work is as-required - Refer to D2.3.**

**A6: Refer to E.2.4 (Addendum 1) for typical frequencies.**

Q7: What are the expectations for water run off when we clean? In the winter, are we required to apply de-icing products afterwards?

**A7: The Site is to be restored to the condition it was prior to the Wash as per D20.**

Q8: In the bid information, it is noted that the as is cleaning is all year round with an estimated 200 hours, the winter hours are December 1- March 31st. Is the over lap of those months with the regular 200 hours on purpose, or are those 200 hours actually April 1st - November 30th?
