Decommission & Legally Remove Existing Concrete Wading Pool, Basin, Vault (incl.

- Drainage Valve & Drainage Lines) and Apron incl. all Base, Reinforcing Steel, Mechanical, and Materials
- Disconnect & Legally Remove Existing Water Service Line and Cap at Property Line
- Disconnect & Legally Remove Existing 3 Drainage Lines and Corrugated Metal Basin. Abandon Lead.
- Demolish & Legally Remove Existing Chain Link Fence Around Entire Wading Pool (North, East, and South of the Small Bit of the West, South of the Wading Pool Building) (110 LM)

- Remove & Legally Dispose of Existing Benches (2)
- Remove & Legally Dispose of Existing Shrubs Along Fence
- Protect Existing Trees Immediately Adjacent to Work Area During Construction
- 8 Existing Play Area and Benches to Remain
- 9 Existing Sand Box and Bench to Remain
- 10 Existing Buildings to Remain
- 11 Existing Granular Path to Remain
