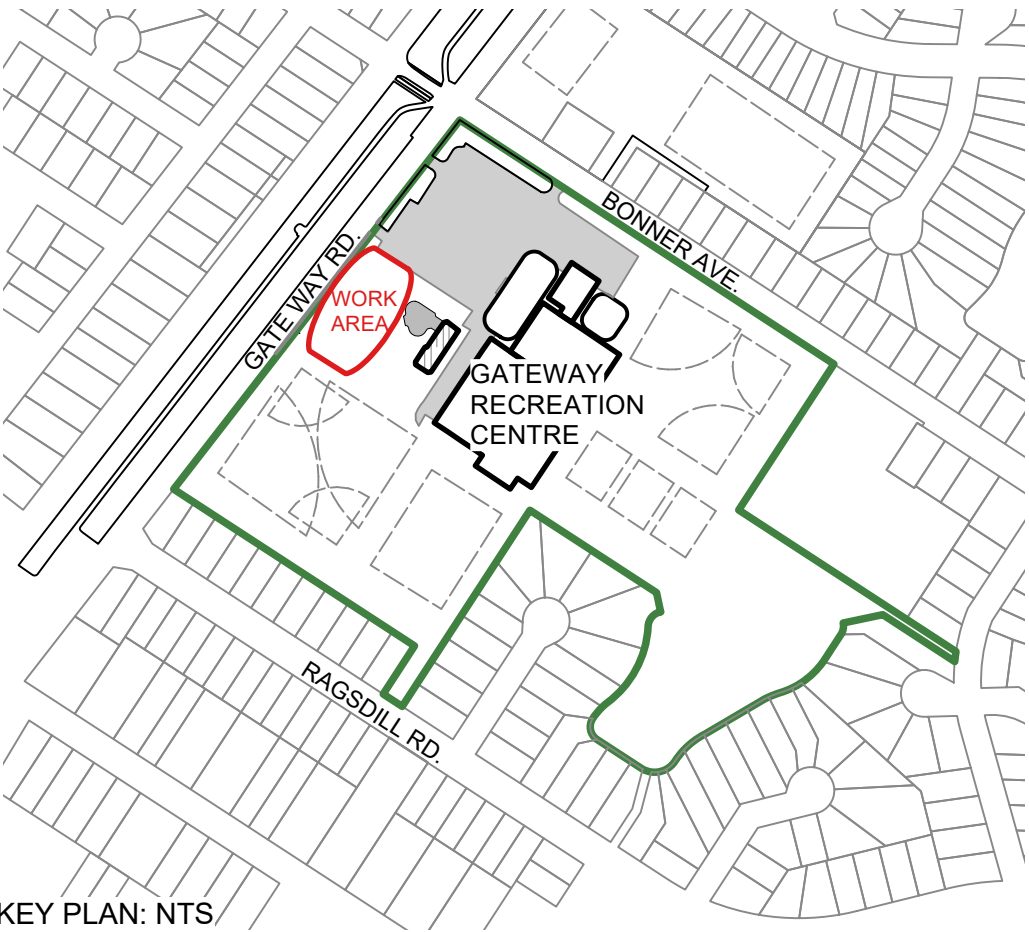


LEGEND
