Performance milestone is achieved.

.1 Restrict tree removal to areas indicated in the Drawings or designated by Contract Administrator.

.2 Tree removal is not permitted during the Environment and Climate Change Canada (Canadian Wildlife Service) 'Zone B4' breeding bird window of April 30 to August 18.

Add: 1.13 Notification

.1 The Contract Administrator will notify the Contractor in writing of observed noncompliance with Federal, Provincial or Municipal environmental laws or

- regulations, permits, and other elements of Contractor's Environmental Protection plan.
- .2 The Contractor after receipt of such notice will inform the Contract Administrator of proposed corrective action.
- .3 Do not take action until after receipt of written approval by Contract Administrator.
