- E2.1 The Contractor shall make available Hot Sand for City crews to pick up in accordance with D11 and the requirements hereinafter specified.
- E2.2 The Contractor shall ensure a minimum of 300 tonnes of Hot Sand be on site and ready for pick up at any given time to meet the potential daily demand.
- E2.3 The quality and characteristics of the material provided by the Contractor will be in accordance with the "Sand" classification from Specification CW2030 Excavation Bedding and Backfill.
- E2.4 Hot Sand to be supplied by an Approved Aggregate Supplier as listed at Approved Aggregate Suppliers.pdf.
- E2.5 Hot Sand to be heated via steaming (or approved alternative method) to ensure a minimum internal temperature of 70° C at the time of pick up.
