PART E – SPECIFICATIONS

- Revise: E2.2.2 to read: Application of herbicide shall be applied on an “as required” basis during the term of the contract, to control annual and perennial weeds in designated turf and landscaped **Priority 2 fenced** areas.
- Revise: E2.2.3 to read: Application of pesticide shall be applied on an “as required” basis during the term of the contract, to control pests in **Priority 2 fenced areas** and shall comply with the following,
- (a) Avoid application during windy conditions or when rain is forecasted within 24 hours;
 - (b) Use of Personal Protective Equipment (PPE) is mandatory for all applicators;
 - (c) All pesticide products must be registered under the Pest Control Products Act and approved by Health Canada's Pest Management Regulatory Agency (PMRA);
 - (d) Applicators must hold a valid Pesticide Applicator Licence issued by Manitoba Agriculture;
 - (e) Application records must be completed within 24 hours and retained for at least 3 years. Records must include: date/time, location, weather conditions, pest targeted, pesticide used, amount applied, applicator name and license number.

QUESTIONS AND ANSWERS

Q1: Can the landscaping maintenance hours be adjusted to commence work earlier.

A1: No, site hours will remain as stated in Part E – Specifications and Drawings.

Q2: Are department call-outs mandatory?

A2: Terms of call outs are stipulated in Part D3 of the Tender document. The rates outlined in Form B

Q3: Is SAFE Work Manitoba's SAFE Work Certified Standard COR™ and SECOR™ mandatory for qualifications to do the work?

A3: COR™ and SECOR™ is preferred and accepted. Alternatively, B13.4 (b) allows for an equivalent qualification process for Bidders that do not currently possess the COR™ and SECOR™ certifications.
