



- CONSTRUCTION NOTES:**
1. ALL WORK AND MATERIALS TO BE IN ACCORDANCE WITH LATEST REVISION OF THE CITY OF WINNIPEG STANDARD CONSTRUCTION SPECIFICATIONS.
  2. LEGAL PLAN AND UNDERGROUND INFORMATION FROM CITY OF WINNIPEG LBIS. CONTRACTOR TO VERIFY ALL UNDERGROUNDS IN THE FIELD.
  3. CONTRACTOR TO TAKE PRECAUTIONARY STEPS TO AVOID DAMAGE FROM CONSTRUCTION ACTIVITIES TO TREES WITHIN THE LIMITS OF CONSTRUCTION.
  4. LOCATION OF EXISTING SERVICES TO BE CONFIRMED IN THE FIELD BY THE CONTRACTOR.
  5. HYDRO POLES AND ANCHORS THAT REQUIRE TEMPORARY SUPPORT, REMOVAL OR REPLACEMENT, TO BE DONE SO AT THE EXPENSE OF THE CONTRACTOR, AS NECESSARY.
  6. LIMITS OF WORK FOR CLEARING AND GRUBBING, RESTORATION OF APPROACHES AND LANDSCAPING TO BE DETERMINED BY THE CONTRACT ADMINISTRATOR.
  7. IF POWER EQUIPMENT OR EXPLOSIVES ARE TO BE USED FOR EXCAVATION ON THIS PROJECT THE CONTRACTOR MUST NOTIFY THE GAS COMPANY OF THE PROPOSED LOCATION OF EXCAVATION, TAKE PRECAUTION TO AVOID DAMAGE TO GAS COMPANY INSTALLATIONS (SEE PROVINCIAL REGULATION 21072 FOR DETAILS) AND OBTAIN EXCAVATION PERMITS PRIOR TO CONSTRUCTION.
