PYROTECHNIC SPECIAL EFFECTS EVENT APPROVAL

CONDITIONS AND REQUIREMENTS

Applicant must ensure the Pyrotechnic Special Effects application is submitted a minimum of 7 days prior to the event. A Pyrotechnic Special Effects Permit Application requires all the following items and the Applicant must:

- 1. Possess a Natural Resources Canada Pyrotechnic card appropriate to the pyrotechnic effects to be used in the display. No person shall purchase, handle, discharge, fire or set off pyrotechnic materials and/or devices until and unless they hold proper authorization for that purpose.
- 2. Demonstrate knowledge and experience applying the standards presented in the Pyrotechnic Special Effects Manual on the part of each individual who will purchase, handle or discharge, fire or set off any Pyrotechnic Special Effects materials and/or devices.
- 3. Provide written permission from the property owner or agent to use pyrotechnic special effects in a venue or a location.
- 4. Present a Certificate of Liability insurance document for the pyrotechnic event in the amount of \$5,000,000.00 or greater.
- 5. Provide detailed site plan information including event description and time frames. A diagram must include the location of the stage, audience, effect locations, distances to spectators as well as the location of safety equipment and personnel.
- Provide detailed product information including a count and description of each Pyrotechnic Effect being used. Product information must include a product name, manufacturer and *UN Number from the ERD list of authorized explosives. (*published by the Explosives and Regulatory Division, Natural Resources Canada)
- 7. Provide documentation that the set, scenery and rigging materials are inherently flame-retardant or have been recently treated to achieve the required flame retardant.
- 8. Specify if the discharge of the devices during the performance will generate substantial amounts of smoke. If so, what measures will be implemented to alleviate excessive smoke conditions?

NOTE: For all events involving pyrotechnic special effects, the permit holder must:

- be knowledgeable of the Fire Safety Plan including the Emergency Procedures contained therein for the evacuation of the audience if necessary.
- ensure that staff members are aware of and understand the Emergency Procedures including the location of available exits.
- formulate an Emergency Contingency Plan including evacuation procedures and location of exits for occupancies that have no Fire Safety Plan.

An inspection of the proposed site and demonstration of the Pyrotechnic Special Effects and related devices may be required prior to issuance or as a condition of an approved permit. An inspection that is required outside of regular business hours (08:00 - 16:30 hrs Monday to Friday) will incur a fee. The demonstration will be required to take place prior to arrival of audience members. As result of the demonstration additional precautions may be required and the permit may be revoked at the discretion of the Fire Prevention Officer in attendance.

Furthermore, any electrical requirements that pertain to electrical firing for fireworks or that are associated with the generation of flames by means of propane or other sources must comply with the Canadian Electrical Code. Additional approvals may therefore be required by other City and/or Provincial jurisdictions.
