CITY OF WINNIPEG CONSTRUCTION NOTICE

TO: Resident/Business on Selkirk Ave or William Ave

RE: 2021-2022 Selkirk Ave and William Ave Pavement Renewals

Please be advised that the reconstruction of sections of Selkirk Avenue and William Avenue will begin in May 2022.

Selkirk Avenue - All Lanes: McPhillips Street to Sinclair Street

Construction start: May 2022

Duration: Estimated completion October 2022 Impacted streets and intersections: Selkirk from McPhillips to Sinclair

William Avenue - All Lanes: McPhillips Street to Arlington Street

Construction start: June 2022

Duration: Estimated completion October 2022 Impacted streets and intersections: William from McPhillips to Arlington

General Overview:

The work will include: reconstruction of the existing roadways, sidewalks and private approaches, installation of new streetlights/traffic signal lights and renewal of some drainage infrastructure.

Traffic Impacts:

- On-street parking will be removed
- William will be restricted to one eastbound lane throughout; westbound traffic will be closed at Arlington
- Selkirk will be restricted to one eastbound lane from McPhillips to Battery Street; Battery to Sinclair will be fully closed
- Work will be completed in multiple stages requiring multiple traffic control configurations
- Closure of side streets and approaches will be required at different times during construction; however, we will make every effort to minimize impacts to traffic and pedestrians and will notify affected properties ahead of time
- Pedestrian access to residences and businesses will be maintained throughout construction, except within the full closure area on Selkirk
- Transit service will be maintained through out construction. Existing Transit stops may be temporarily relocated or closed on a case-by-case basis, depending on construction activities in the immediate vicinity
- Westbound Transit routes on Selkirk Avenue and William Avenue will be rerouted and signed
