CITY OF WINNIPEG PRE-CONSTRUCTION NOTICE

TO: Businesses/Residents

**RE: St. Mary Ave from Memorial Blvd to Portage Ave
Colony St from St. Mary Ave to Portage Ave**

Please be advised that St. Mary Avenue from Memorial Boulevard to Portage Avenue and Colony Street from St. Mary Avenue to Portage Avenue is scheduled for pavement renewal starting May 30, 2022.

Construction start: May 30 2022

Duration: 16 weeks

Impacted streets and intersections: Portage Avenue, Memorial Boulevard, Spence Street, Balmoral Street, Good Street, Colony Street, St. Mary Avenue

Work on St. Mary Avenue includes:

- Concrete roadway reconstruction
- Upgrade the existing painted bike lanes to protected bike lanes
- New pedestrian corridor at Colony Street
- New street lighting
- Drainage improvements
- Sidewalk reconstruction
- Private approach renewals
- Watermain renewal at Spence Street

On St. Mary Avenue the painted bike lanes will be upgraded to protected bike lanes by adding raised curbs to provide separation between vehicles and cyclists.

Work on Colony Street includes concrete roadway patching and asphalt overlay. Parking and loading will be temporarily stripped during construction. Sidewalk, private access and garbage/recycling pick up will not be affected.

Temporary implications:

- During construction traffic on St. Mary Avenue will be limited to one westbound lane
- Turning movements will be restricted off St. Mary Avenue
- Access to businesses and parking lots will be maintained as much as possible
- Sidewalks will be maintained on one side of the street at a time
- The pedestrian corridor at Balmoral Street will be maintained at all times
- On-street parking and loading will be stripped during construction.

- Cyclists are asked to choose an alternate route during construction on St. Mary Avenue or to share the road with other vehicles as the curb separating the bike lane from vehicle lanes will be installed in the final stage of construction
