CITY OF WINNIPEG CONSTRUCTION NOTICE

TO: Residents

**RE: 2022 Local Street and Alley Renewal Project – Spruce Street/Clifton Street Alley
Reconstruction – The block bounded by Spruce St., Clifton St., Sargent Ave. and Ellice Ave.**

Please be advised the above project will soon begin.

Construction start: **Phase 1 - Monday May 8, 2023**
Duration: 10 weeks

The construction will be completed in the following two phases:

**Phase 1: #977 to #1133 Spruce Street, #958 to #988 Clifton Street, #1010 to #1034 Clifton Street,
#1122 Sargent Avenue, and #1153 Ellice Avenue**

Phase 2: #1120 to #1110 Sargent Avenue, #1141 to #1149 Ellice Avenue, #940 to #956 Clifton Street,
#990 to #1008 Clifton Street, and #1038 to #1042 Clifton Street.

Work will include the renewal of land drainage sewer inlets, excavation of the existing lane, and placement of sub-base and base course material followed by an asphalt pavement surface. This work will be followed by driveway/approach restorations and boulevard grading where required.

During construction, **the alley will be closed to ALL traffic**. Residents are asked to park elsewhere during the construction period.

Please note, regular garbage pickup and recycling days will not change, however garbage and recycling **for ALL alley residents** should be placed on the front street for pickup for the duration of the construction project. Due to the potential of parked cars, we are asking affected residents on Clifton Street to place their garbage and recycling bins on the East boulevard (across the street from your residences) for the duration of construction. Collection of both services will resume in the alley once the entire alley is reopened.

Anyone with accessibility needs, moving requirements, any underground appurtenances, such as sprinkler systems, lighting cables, etc. within 6 metres (20 feet) of the alley or any other questions are asked to contact Andrew Boboski from WSP Canada Inc. at (204) 477-7608, during regular working hours or by email at info.wpg@wsp.com.

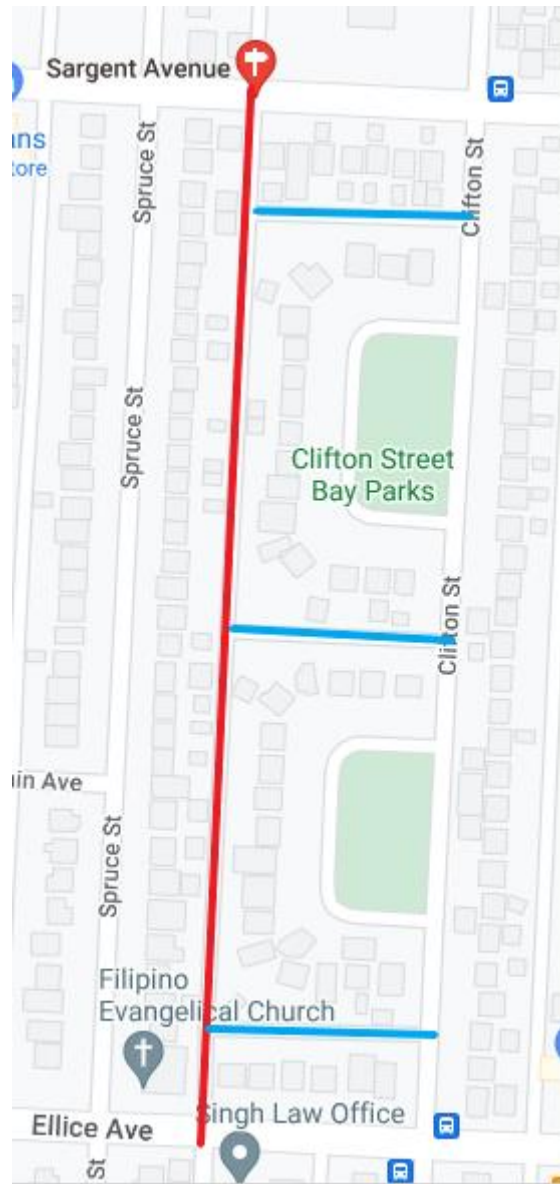
