**CONSTRUCTION NOTICE** 

TO: BUSINESSES/RESIDENTS OF GRAHAM AVENUE

**RE: WINNIPEG TRANSIT IMPROVEMENTS:** 

**GRAHAM AVENUE – GARRY STREET TO MAIN STREET** 

Changes are coming to Graham Avenue:

- Winnipeg Transit is launching an all-new transit network June 29, 2025
  - The Primary Transit Network (winnipeg.ca/primarytransitnetwork) moves buses off most of Graham in favour of more efficient routing
  - The exception will be between Garry and Main, where the new D11 and D12 bus lines will travel
- Ahead of Transit changes, Winnipeggers provided feedback on the Re-imagining Graham Avenue project (engage.winnipeg.ca/graham-avenue)
  - This project identified options to make Graham a signature street, while maintaining it as a key link in the bike network

While funding has not yet been allocated for permanent changes on Graham Avenue, some construction is required now to accommodate the new bus network.

Construction will begin June 9, 2025 and will be completed June 23, 2025. It will include:

- Moving Winnipeg Transit service off most of Graham Avenue
- Installing new bike lanes and traffic signals between Garry Street and Main Street
- Removing vehicle traffic from Graham Avenue between Main Street and Garry Street to accommodate a new pedestrian corridor

## During construction:

- Winnipeg Transit will operate one-way eastbound from Garry Street to Fort Street
  - Stops may be temporarily moved
- Motor vehicle traffic will be two-way from Fort Street to Main Street
- Sidewalks will remain open
- There will be no on-street parking
- Curb lane closures will be required on Main Street at Graham Avenue to facilitate sidewalk and traffic signals work
