## **CITY OF WINNIPEG CONSTRUCTION NOTICE**

**TO: Resident/Business on Stafford Street**

**RE: 2019-2023 Stafford/Taylor/Corydon Pavement Renewals – Tender 2 2022-2023**

Please be advised that the reconstruction of sections of Stafford Street will begin in May 2022. This work has two primary phases:

### **2022 work: Stafford Street**

**All Lanes: Corydon Avenue to Scotland Avenue**

**Southbound Lanes: Scotland Avenue to Ebby Avenue**

Construction start: Early to Mid-May 2022

Estimated completion: October 2022

### **2023 work: Stafford Street**

**Northbound Lanes: Scotland Avenue to Ebby Avenue**

**All Lanes: Ebby Avenue to Pembina Highway**

Construction start: Early to Mid-May 2023

Estimated completion: Roadworks to be completed by October 2023

Another notice will be provided with more exact scheduling and further details approximately two weeks prior to the commencement of construction.

### **Traffic Impacts:**

- On-street parking will be removed
- Traffic will be restricted to one lane in the northbound direction, the southbound direction will be closed
- Left turns to and from Stafford Street will be restricted with the exception of key intersections including Warsaw Avenue, Garwood Avenue and Ebby Avenue
- Eastbound to northbound left turns will be allowed on Grant Avenue and Corydon Avenue at Stafford Street.
- Work on Stafford Street between Pembina Highway and Corydon Avenue will be completed in multiple stages, and will require several traffic control configurations.
- Closure of side streets and approaches will be required at different times during construction; however, we will make every effort to minimize impacts to traffic and pedestrians.
- Closures of private approaches will be discussed with the affected business/resident prior to the closure taking place.
- Pedestrian access to residences and businesses will be maintained throughout construction.
- Transit service will be maintained through out construction. Existing Transit stops may be temporarily relocated or closed on a case-by-case basis, depending on construction activities in the immediate vicinity.
- Southbound Transit routes on Stafford Street will be rerouted to Harrow Street.

**Water service during construction – On Stafford Street between Garwood Avenue and Carter Avenue:** We may have to provide you with a temporary water service from time to time, by connecting an overland hose to your outside tap or within your building. To attach this hose, we will need to enter your property.

If we cannot provide a temporary water service, we will coordinate with you and work to schedule any interruption so it will be the least disruptive.

We will also have to shut off your water service for a short time on a few occasions and will try to give you 24 hours' notice. If you are a business, we will do everything we can to schedule this outside of your regular business hours.

We may have to shut off your water without notice. If this happens, we will restore your service as quickly as possible, usually within four to six hours.

Even though the new water main is disinfected once it is installed, you may find that the water tastes a little different and is cloudy. This is common after water main work. The water will return to normal within a few days. You can use the water and there is no need to take special precautions.

- Your garbage and recycling collection will not be affected
