CITY OF WINNIPEG CONSTRUCTION NOTICE

TO: BUSINESSES/RESIDENCE

RE: Second notice - 2020 Regional Street Renewal Program - Sargent Avenue Reconstruction, Erin Street to Arlington Street

Construction on Sargent Avenue from Erin Street to Arlington Street is scheduled to begin the first week of May as part of the 2019-2023 Erin/Wall/Sargent Pavement Renewals Project.

We understand that now is a time of much uncertainty, but want to assure you we are proceeding on the assumption that construction season will continue. We will be using alternate means of communication to ensure that discussions which would have formerly took place in person still occur. If you anticipate being away from your business and/or mailbox for an extended period of time, please contact us with an alternative address, phone number, and email at which we can reach you leading up to and during construction.

Construction Start: Week of May 4-9, 2020

Duration: 6 Months

Impacted Streets and Intersections: Sargent Avenue from Erin St to Arlington St

The Sargent reconstruction will include excavation of the existing roadway in both directions, construction of a new concrete pavement structure, reconstruction of the sidewalks, and re-grading of the boulevards. The work is expected to be completed by the end of October 2020. A watermain renewal from Erin Street to Ingersoll Street is also a part of this project.

Traffic implications:

- Phase 1 - Sargent Avenue will be converted to a one-way street in the westbound direction for approximately three months.
- Phase 2 - Sargent will be converted to a one-way street in the eastbound direction.
- On-street parking will be prohibited throughout the entire construction period.
- A notice will be delivered and posted on winnipeg.ca ahead of the directional switch.

- Access to businesses will be accommodated, and both pedestrian access and one-way bus service will be maintained on Sargent Avenue.
- Opposite direction vehicles will be rerouted down either Ellice Avenue or Wellington Avenue.
- Many connecting side streets and back lanes intersecting with Sargent Avenue will be closed in order to reconstruct the intersections.

We recognize this project will cause some inconvenience and apologize for the disruption.
