## **CITY OF WINNIPEG CONSTRUCTION NOTICE**

**TO: Businesses/Residents**

**RE: Maryland Street Pavement Renewals**

---

Please be advised that Maryland Street from Broadway to Cornish Avenue will soon begin construction.

**Construction start: June 1, 2020**

**Duration: 14 weeks**

**Impacted streets and intersections: Maryland Street from Broadway to Cornish Avenue**

Maryland Street will undergo full concrete reconstruction, including full removal of the existing roadway, replacement of drainage infrastructure, placement of new concrete pavement, and sidewalk reconstruction.

During the project, the bike lane along Maryland Street will be closed and cyclists will be rerouted at Broadway to Walnut Street. Parking will be removed along both Maryland Street and Sara Avenue.

The project will have the following effects on access and lane closures:

**Stage One: reconstruction of east and centre lanes [8 Weeks]**

- Full closure of the east and centre lanes of Maryland
- Phase One (June 1 – Early July)
  - Access to Sara Avenue and Food Fare will be removed.
  - Access to and from Wolseley Avenue east of Maryland Street will be restricted for two weeks, starting Mid June.
- Phase Two (Early July – Late July)
  - Access to Cornish Avenue will be redirected onto a temporary roadway.
  - Access to and from Westminster Avenue east of Maryland Street will be restricted for two weeks, starting Early July.

**Stage Two: reconstruction and rehabilitation of west lane [6 Weeks]**

- Full closure of west lane of Maryland
- Phase One (Late July – Late August)
  - Access to Fawcett Avenue, Purcell Avenue, and Dundurn Place will be restricted, with alternate access available via the back lane, which can be accessed from Alloway Avenue, Westminster Avenue, and Wolseley Avenue.
- Phase Two (Late August – Early September)
  - Access to Alloway Avenue and Woodrow Place will be restricted, with alternate access available via Fawcett Avenue or Purcell Avenue and Wolseley Avenue, respectively.

- Westbound traffic along Westminster Avenue east of Maryland will be restricted to left turns only during this phase.
