RE: CITY OF WINNIPEG TRURO CREEK CULVERTS REPLACEMENT AT WINCHESTER STREET AND LINWOOD STREET AND ASSOCIATED ROAD WORK

The road reconstruction phase of the culverts replacement project is scheduled to begin Monday, May 14, 2018, weather permitting, and will take approximately **nine (9) weeks** to complete.

The work will include: pavement removal and excavation, placement of new pavement structure including concrete pavement, construction of new concrete curbs, renewal of concrete sidewalk, and landscaping and boulevard grading.

Winchester Street and Linwood Street between Ness Avenue and Silver Avenue will be closed to all traffic in the vicinity of the road reconstruction. Linwood St access to the Linwood Street / Winchester Street alley (from Silver Avenue to Linwood Street) will not be maintained during construction. Also, Winchester Street access to the Winchester Street alley (from Winchester Street to Ness Avenue) will not be maintained during construction. The roadworks contractor for the project is JC Paving Ltd. (204) 989-4700.

Parking & Pedestrian Access

Parking on the street will not be permitted in the immediate vicinity of the road reconstruction. These areas will be signed and/or cordoned-off accordingly. Pedestrian access will not be maintained throughout the duration of the road reconstruction.

Emergency Services

Emergency services access will be maintained throughout the duration of the project. To keep residents safe please keep away from construction equipment and the work site at all times.

Garbage and Recycling

Garbage and Recycling will continue to be picked up at the regular times. Please ensure that your house number is clearly marked on both your garbage bin and recycling bin. The contractor will be responsible for relocating your bins to an area where they can be accessed by the collection trucks and the emptied bins will then be returned before the end of the day.

Notify the City's representative, identified below, of any accessibility needs, moving requirements, social functions, or underground appurtenances (sprinkler systems, lighting cables, etc.) within 6 metres (20 feet) of the curb.

We recognize this project will cause some inconvenience to residents and apologize for the disruption.
